Dear Waterford Sportsman's Club Member:

This letter is mainly to inform you of the membership renewal process for the upcoming 2018-2019 membership year. As you are aware, your current membership will expire on September 30, 2018.

To obtain a renewal form for your membership, please go to the club website www.wsclub.ca. Once you are on the website go to the bottom right of the screen and select membership. You will find a fillable pdf of the renewal form here. Please complete the form by filling in all the blanks, print it and sign it. You may also attend the club to obtain a blank form to complete.

There are different options for returning the form and payment to the club. Your options are to:

1. Mail the completed form & payment by cheque, money order, or bank draft payable to Waterford Sportsman's Club, PO Box 801, Waterford, ON, N0E 1Y0.
2. Bring the completed form & cheque, money order, or bank draft to the club during regular club hours. The club regular hours are noon to 9pm on Tuesday and Thursday and 9am to 5pm on Saturday.

If you choose to send your payment in the mail, please note that we are not responsible for lost or misdirected mail. Your membership card(s) will be available at the club for pickup during regular club hours approximately 4 weeks after we receive your completed form and payment. If you would prefer to have your membership card(s) mailed to you, please include a self-addressed, stamped envelope with your completed renewal form. If someone is picking up your membership card(s) for you, please send a note with them signed by you authorizing them to pick up your membership card(s).

The membership renewal rates for the upcoming year are:

- \$150.00 for a single adult, 18 years of age or older
- \$195.00 for a family of two with one vote *
- \$225.00 for a family of two with two votes *
- \$25.00 for a junior, under 18 years old and sponsored by a member

*A family may consist of more than two members but each additional member above two in the membership will need to pay \$15 each for insurance. A family is defined as a spouse &/or partner &/or any children under 18 living at the same address as the primary and secondary members.

On another note, please be aware that there will be discussions and potentially very significant financial decisions made on the outdoor rifle range project during our next regular membership meeting on Thursday August 16th. The meeting will commence at the clubhouse at 7pm. All members are encouraged to attend. It is expected that follow up discussions and decisions with regard to the outdoor rifle range will take place at the following meeting, which is also our Annual General Meeting, on Thursday September 20th. This meeting will also commence at 7pm at the clubhouse.

For those that are not familiar with the process for the Annual General Meeting, this meeting will also include the election of the executive positions, by the membership, for the upcoming year to end September 30, 2019. There are a number of executive positions that will be vacant and will need to be filled at the Annual General Meeting. Please consider putting your name forward to fill one of the vacant positions. You will require another member to put your name forward and a second member to second the nomination. You, as well, should be present at the Annual General Meeting.

If you are interested in becoming a member of the executive but would not like to put your name forward for an elected position, you might want to consider putting your name forward for a director position to help with the desk duty. The elected executive choose the directors after the Annual General Membership meeting. To have your name considered, please contact one of the current executive members and provide your contact information to them prior to the Annual General Meeting on September 20th.
